

Website Terms and Conditions of Use

1. General Terms and Conditions of Use

Accessing and browsing this Website implies the acceptance on the part of the user ("User") of the provisions set out in the terms and conditions of use (hereinafter "Terms and Conditions of Use"). Users that do not intend to accept the contents of the Terms and Conditions of Use shall discontinue browsing the Website.

The Website is managed by Calzedonia S.p.A. (hereinafter "Calzedonia" and jointly with the other companies of the Group, "Calzedonia Group") which reserves the right, at its own discretion, to change the Terms and Conditions of Use, at any time and without prior notice. Using the Website after making said changes implies the acceptance of the Terms and Conditions of Use in the modified version and the full acceptance of their mandatory nature.

There are multiple features in the Website to inform the User about the products sold by the Calzedonia Group and the services present in the Website, like for example, the possibility for Users to register to the Website, enrol to the Loyalty Programme, register to a mailing list to receive newsletters and information regarding initiatives of the Website and participate to promotional initiatives.

2. Intellectual Property Rights
